### INVITATION TO APPLY FOR ELIGIBILITY AND TO BID Materials Management Services Division NEGOTIATED PROCUREMENT NP MMSD 2009-031

Hauling of Diesel Fuel Oil from Filpride Mandaluyong to Basco DPP, J.O. Supply of Labor, Tools, Materials, Equipment & Supervision of works related to Draining of Septic Tanks at Bagac & Morong Bataan, .O. Supply of Labor to perform General Services to include replacement of parts for Mitsubishi Rosa Coaster Model 1998

1. The NATIONAL POWER CORPORATION (NPC), through its approved Corporate Budget of CY 2009 intends to apply the sum of **(Please see schedule under item no. 8)** being the Approved Budget for the Contract (ABC) to payments under the contract listed below. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. NPC now invites Bids from eligible Bidders for GOODS listed below. Delivery of the GOODS is required by the date indicated in the bid documents. The description of an eligible Bidder is contained in Section II of the Bidding Documents, ITB.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.
4. Interested Bidders may obtain further information from NPC and inspect the Bidding Documents at the address given below from 1:30 PM to 4:30 PM from Monday to Friday. Issuance of Bidding Documents shall start on **September 7, 2009** from 1:30 p.m. to 4:30 p.m. Monday to Friday. No Bid Documents shall be issued on the date of bidding.
5. A complete set of Bidding Documents may be secured by interested Bidders from the address below. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
6. Bids and eligibility requirements must be delivered to the address as listed in the Bid Documents on or before the dates stated below. All Bids must be accompanied by a Bid security in the form as stated in the Bid Documents. Late Bids shall not be accepted.
7. Bid opening shall be on the dates specified hereunder at the designated NPC function rooms. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
