WHEREAS, the BAC in its meeting on **16 September 2024** recommends the award of contract to **R4L ENTERPRISES** as the Lowest Calculated and Responsive Quotation (LCRQ) in the total amount of **Php 100,824.10**;

WHEREAS, the end user requested cancellation of subject PR for item due to reassignment of BNPP personnel in Finance Department at NPC Head Office, hence reduction on the number of chairs is deemed necessary and appropriate;

WHEREAS, the end shall prepare a new PR for re-processing and re-advertisement of the said requirements with the accurate number of chairs needed in BNPP office;

WHEREAS, Section 35.6 (a) of the 2016 Revised IRR of R.A. No. 9184 provides:

...xxx... the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to:

a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;

b) ...xxx...

c) ...xxx... "

WHEREAS, Section 41 (c) of the 2016 Revised IRR of R.A. No. 9184, to further provides:

The HoPE reserves the right to reject any and all Bids, declare a failure of bidding, or not award the contract in the following situations:

(a)XXXXX.....

(b)XXXXX.....

(c) *For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows: (1) if the **physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE**; (ii) if the source of funds is no longer necessary as determined by HoPE; (iii) if the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity.*
