2. Delivery Period

The delivery period for the entire Scope of Work is seven (7) calendar days reckoned from receipt of Notice to Proceed (NTP).

3. Delivery Point

4. Bid Submission

The Bidder shall submit their bids through their authorized representative or in the manner of submission as prescribed in the Request for Quotation (RFQ).

5. Late Bids

Any Bid submitted after the deadline for submission and receipt of Bids shall not be accepted by NPC.

6. Bid Prices

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A Bid submitted with an adjustable price quotation shall be treated as non-responsive.

7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from the date of bid submission.

8. Eligibility Criteria

- Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Quotation (LCQ).

9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which do not to comply with the requirements of the tender shall be considered non-complying.

10. Post-qualification

Submitted documents of the LCQ shall be subjected to post qualification evaluation. The bid that is rated as "PASSED" during the Post-Qualification activity shall be declared as the Single / Lowest Calculated Responsive Quotation (S/LCRQ).

11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

12. Notice to Supplier

- The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
- b. Failure to secure the PO/NTP by the supplier within the said period shall cause the cancellation of the same and shall warrant the imposition of penalties as prescribed by law.

13. PO Effectivity

a. The PO shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

14. Terms of Payment

NPC shall pay the CONTRACTOR within thirty (30) days from receipt of the complete supporting documents as required by NPC. Checks will be prepared for payment to the CONTRACTOR subject to existing taxes.

15. Warranty

Unless otherwise provided in the RFQ, the warranty period shall be a minimum of one (1) year from the date of final acceptance by the end-user.

16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent(1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions shall be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in Section 69 (Imposition of administrative penalties) should there be infractions committed.

Should there be infractions, the appropriate sanctions provided under Section 69 (Item 69.1) of The 2016 Revised IRR shall be imposed against the bidder.

20. Reservation Clause

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.

TERMS OF REFERENCE SMALL VALUE PROCUREMENT "BASIC LINEMAN TRAINING COURSE"

1. Background:

The Basic Lineman Training Course (BLTC) is a specialized training course that equips individuals with the essential skills and knowledge needed to install, maintain, and repair electrical power systems. This program combines classroom instruction with practical field training to cover key areas such as electrical principles, technical skills for working on power lines, safety protocols, regulatory compliance, and problem-solving techniques. By emphasizing both theoretical knowledge and hands-on experience, the program prepares participants to safely and effectively perform the demanding tasks required of a lineman, ultimately enabling them to ensure reliable electricity distribution.

2. Objective:

The BLTC aims to develop and equip the new and existing linemen of SPUG Luzon Operations Department with the required skills and competencies for their linemen job as well as to provide recommendations for improving the efficiency and effectiveness of the line work.

3. Approved Budget Cost:

The Approved Budget Cost for this procurement amounts to P664,099.00 (VAT inclusive).

4. Mode of Procurement

The mode of procurement for this project is Small Value Procurement.

Training Facility:

Training sessions will be conducted at the training facility of the Small Power Utilities Group (SPUG) located at Minuyan, Bulacan.

6. Scope of the Service:

The service shall cover the following:

- c. <u>Training Module Design</u> Detail of the module design including presentation materials shall be submitted to the Training & Development Division, Human Resources Department (TDD, HRD), in hard and soft copies at least two (2) weeks before the conduct of the program.

7. Methodology:

The training will be conducted for 35 persons involving classroom sessions and skills demonstrations, hands-on applications, and appropriate knowledge/practical assessments. This will be participative and interactive in an adult learning environment, providing a combination of the following:
