All prospective bidders and authorized copyholders of the Bid Documents of the above-mentioned project are hereby informed of the following changes:

#### **A. SECTION III – BID DATA SHEET (SINGLE LARGEST COMPLETED CONTRACT), ITB CLAUSE 5.3**

For this purpose, similar contracts shall refer to Supply, Delivery, Installation, Test and Commissioning or Construction of Power Facilities, Installation, Test and Commissioning of <b>"Unit Diesel Generator – Transformer"</b> with generator capacity of at least 40kW Prime or Continuous Power and Associated Power Transformer of at least 50kVA rating.  For clarity, the Diesel Generator stated herein should be directly connected to the Power Transformer.	For this purpose, similar contracts shall refer to Supply, Delivery, Installation, Test and Commissioning or Construction of Power Facilities, Installation, Test and Commissioning of Diesel Generating Set/s with at least one (1) unit capacity of 40kW Prime or Continuous Power with Power Transformer/s of at least 50kVA rating.

Only the original copy will be read and considered for the bid.</p> <p>Any misplaced documents outside of the <b>Original</b> copy will not be considered. The photocopy is <u>ONLY FOR REFERENCE</u>.</p> <p>The Procuring Entity, may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.</p> <p>If the Procuring Entity allows the submission of bids through online submission or any other electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus automatically disqualified.</p>
