WHEREAS, NPC accepted the said bid of the CONTRACTOR;

consideration of the mutual covenants and stipulations hereinafter provided, the parties hereto have agreed as follows:

# ARTICLE I DOCUMENTS COMPRISING THE CONTRACT

The following documents are hereby incorporated and made part of this Contract as though fully written out and set forth herein insofar as they are not inconsistent with the terms hereof:

- Terms of Reference for the Massive Termite Control and General Pest Control Services at NPC Head Office, Diliman, Quezon City, HO-TFM21-017 and HO-TFM21-022 / SVP210311-NC00072;
- 2. Post Qualification Report dated 06 May 2021;
- 3. Bid Opening Report dated 23 March 2021;
- 4. CONTRACTOR's bid proposal dated 11 March 2021;
- 5. Notice of Award dated 31 May 2021;
- 6. Notice to Proceed

The documents mentioned above shall collectively be referred to as "Contract Documents".

In the event that there is any discrepancy/inconsistency between the provisions of the Contract and the Contract Documents mentioned above, the former shall govern. Should there be any inconsistency/discrepancy, among the Contract Documents, the document with the latest date shall prevail.

# ARTICLE II SCOPE OF WORK

# **HO-TFM21-017 – Massive Termite Control and Soil Poisoning Treatment at NPC Head Office**

- 1. The chemicals shall be delivered and deposited to Transportation and Facilities Management Division (TFMD) representative at NPC Head Office, Diliman, Quezon City for approval not later than fifteen (15) calendar days, upon receipt of the Notice to Proceed and shall be withdrawn and used at the time of application for treatments. The required expiration of chemicals shall be minimum of one (1) year from the date of delivery.
- 2. The chemicals to be used for the services shall have passed and registered with the Food and Drugs Administration (FDA) or National Committee on Urban Pest Control (NCUPC).

- Free services "On Call Basis" in case there are sudden infestations in between schedules at no cost to NPC as warrant for its products and services.
- CONTRACTOR shall strictly observe Safety and Security standards/precautions re-inspect serviced area and with proper coordination with TFMD authorized representative.

#### HO-TFM21-022 - General Pest Control

- 1. The chemicals shall be delivered and deposited to Transportation and Facilities Management Division (TFMD) representative at NPC Head Office, Diliman, Quezon City for approval and shall be withdrawn and used at the time of application for treatments. The required expiration of chemicals shall be minimum of one (1) year, from the date of delivery.
- 2. Weekly or 4x/month spraying/application and treatment of approved chemicals/solutions in the extermination of disease-transmitting, destructive crawling and flying insects at NPC Head Office.
- Quarterly thermal fogging/application against structural pest (Termites and Woodborers) by spraying/dusting using approved chemicals at NPC Head Office.
- 4. Prior to fumigation/thermal fogging/misting, the contractor should submit to TFMD-GSD, approved permit (if necessary) obtained from the Bureau of Fire Protection (BFP).
- The chemical/s to be used for the services shall have passed and registered with the Food and Drugs Administration (FDA) or National Committee on Urban Pest Control (NCUPC).
- Free services "On Call Basis" in case there are sudden infestations in between schedules at no cost to NPC as warrant for its products and services.
- 7. CONTRACTOR shall strictly observe Safety and Security standards/precautions, re-inspect serviced area and with proper coordination with TFMD authorized representative.
- 8. CONTRACTOR shall have exterminator License/Certificate to operate from Fertilizer and Pesticide (FPA)

## ARTICLE III CONTRACT DURATION

CONTRACTOR shall complete all the works specified in the terms of reference within one (1) month, for PR No. HO-TFM21-017 and twelve (12) months for PR No. HO-TFM21-022, reckoned from the receipt of Notice to

### ARTICLE IV PAYMENT

For and in consideration of the WORKS to be undertaken by the CONTRACTOR as specified in Article II hereof, NPC shall pay the CONTRACTOR in Philippine Pesos and in accordance with the Contract documents the amount of **TWO HUNDRED EIGHTY SEVEN THOUSAND PESOS ONLY (P 287,000.00)**. Breakdown are as follows:

The terms of payment for PR No. HO-TFM21-017 shall be thirty (30) days upon completion of services, acceptance of the end-user and submission of complete documents/attachments.

The terms of payment for PR No. HO-TFM21-022 shall be on a monthly basis in the amount of Fourteen Thousand Five Hundred Pesos (P14,500.00), The CONTRACTOR shall submit the service acknowledgement report at least five (5) days after the scheduled maintenance/service with their Service Invoice attached.

#### ARTICLE V GUARANTEE

The CONTRACTOR shall provide three (3) months warranty for the expendable supplies and one (1) year in the case of non-expendable supplies after final acceptance by the end-user of the delivered items.

#### ARTICLE VI LIQUIDATED DAMAGES

Should CONTRACTOR fail to satisfactorily deliver any or all of the Goods and/or to perform the Services within the period/s specified in the Contract, inclusive of duly granted time extensions if any, NPC shall, without prejudice to its remedies under this Contract, and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one (1) percent of the cost of unperformed portion for

every day of delay until actual delivery or performance. Once the amount of liquidated damages reaches ten percent (10%) NPC may rescind or terminate the Contract without prejudice to other courses of action and remedies open to it.

#### ARTICLE VII WARRANTY CLAUSE

CONTRACTOR hereby warrants that he or his representative has not offered or paid, directly or indirectly, any government officer and NPC official or employee any consideration or commission for the Contract nor has he or his representative exerted or utilized any corrupt or unlawful influence to secure or solicit this Contract for any consideration or commission; that the CONTRACTOR will not subcontract any portion or portions of the scope of work of the Contract awarded to him to any official or employee of the NPC and to the relatives within the 3rd degree of consanguinity or affinity of NPC's officials who are directly and indirectly involved in Contract awards or project execution; and that if any commission is being paid to a private person; he shall disclose the name of said person and the amount being paid; and that any violation of this Warranty shall constitute sufficient ground for the rescission or cancellation of this Contract; or the reduction from the Contract Price of the consideration or commission paid without prejudice to the filing of any action for the violation of RA No. 3019 as amended (otherwise known as the Anti-Graft and Corrupt Practices Act) and/or other applicable laws against the CONTRACTOR and/or his representative and/or the erring NPC official(s) and employee(s).

# ARTICLE VIII VALIDITY CLAUSE

If any term or condition of this Contract is held invalid or contrary to law, the validity of the other terms and conditions hereof shall not be affected thereby.

# ARTICLE IX GOVERNING LAW

This Contract shall be governed by and construed in accordance with the laws of the Republic of the Philippines.
