Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served to **SALV-C QUINT INDUSTRIAL SUPPLY & ENGINEERING SERVICES**, for having submitted the Single Calculated and Responsive Bid for the Replacement of RWS Diaphragm Valve with Pressure Control, AG2 under PR No. MA-A2M22-093 in the total contract amount of One Million Nine Hundred Ninety Nine Thousand Pesos (PHP1,999,000.00) only.

Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- b) Surety Bond callable upon demand issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price;
- c) Any combination of the forgoing proportionate to share to form with respect to the total amount of security.

Likewise, you are to secure the Certificate of Acceptable Performance Security from FD within eight (8) calendar days from receipt of the copy of this notice and submit the same to PSS-LD.
