Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **CERTIFICATION INTERNATIONAL PHILIPPINES, INC.** for having submitted the **Single Calculated and Responsive Bid (SCRB)** for the **Service Contract for the ISO 9001-2015 Certification and Surveillance Audits of NPC** under **PR No. HO-CAG25-003 (Item Nos. 1-3)** in the total contract amount of **One Million One Hundred Seventy Six Thousand Pesos (Php 1,176,000.00) only**.

Please be reminded of the following: a) Your price validity is one hundred twenty (120) calendar days; b) Contract Duration is within three (3) years and Re-certification Audit is within sixty (60) calendar days reckoned from issuance of Notice to Proceed; and c) Project sites are at various NPC Offices indicated in Section VI – Technical Specifications of the Bidding Documents.

You are hereby required to secure and submit to the *Manager, Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department*, the Certificate of Acceptable Performance Security issued by the Trade & Insurance Division, Treasury Dept. (TID, TD). The Performance Security is in any of the following forms to be submitted to TID, TD within **five (5) days** from receipt of this Notice of Award:

- Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price.
- Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price. The Insurance Company that will issue Performance Security must be acceptable to the National Power Corporation (Annex A1).

Failure to submit on time the Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.

Contract and Notice to Proceed will be released upon submission of the Certificate of Acceptable Performance Security to *MSSPD, Logistics Department issued by Trade and Insurance Division*.
