Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **RUREX FABRICATION AND TRADING CO., INC.** for having submitted the Lowest Calculated and Responsive Bid (LCRB) for the **Supply and Delivery of Mechanical Spare Parts for 4x600KW Cummins Engine, Model No. KTA38-G1 Chongqing China, Serial Nos. 41237070, 41309790 & 41309783 for Romblon Diesel Power Plant under PR No. S1-ROM22-005 (Item Nos. 1 – 30), in the total contract amount of One Million Six Hundred Eighty One Thousand Six Hundred Twenty (₱ 1,681,620.00) only.**

1. Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that is shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
2. Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be acceptable to National Power Corporation (Annex A);
3. Performance Securing Declaration (Annex B).

Failure to submit an Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.

Purchase Order (PO) and Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to *MSSPD, Logistics Department by Trade and Insurance Division*.
