Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **DYNAMIC POWER & MARINE INDUSTRIAL HARDWARE, INC.** for having submitted the Single Calculated and Responsive Bid (SCRB) for the **Supply and Delivery of Various Mechanical Spare Parts for Weichai Generator Sets of SPUG-WMOD Plants** under PR Nos. **S3-PDM22-001 (Item Nos. 1-11) and S3-LGY22-001 (Item Nos. 1-57)** in the total contract amount of **Two Million Nine Hundred Seventy Thousand Five Hundred Thirteen Pesos (₱ 2,970,513.00) only.**

Please be reminded of the ff: a) Your price validity is one hundred twenty (120) days from bid opening date; b) Delivery period is within one hundred twenty (120) calendar days from issuance of NTP; and c) Delivery site is at NPC, AFD Warehouse, Gov. Cummins Ext., Zamboanga City.

You are hereby required to secure and submit to the *Manager, Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department*, the Performance Security in any of the following forms within **five (5) days** from the date of receipt of this Notice of Award:

- a.) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that is shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- b.) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price. The Insurance Company that will issue Performance Security must be accredited by the Insurance Commission and acceptable to the National Power Corporation (Annex A);
- c.) Performance Securing Declaration (Annex B).

Failure to submit an Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.

Purchase Order (PO) and Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to *MSSPD, Logistics Department by Trade and Insurance Division.*
