No. INFRA2022-AG2-021 in the total contract amount of Three Million Nine Hundred Ninety Nine Thousand Six Hundred Eighty Eight & 00/100 Pesos (PHP3,999,888.00).

- b) Bank Draft/Guarantee or Irrevocable letter of credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank in a sum equivalent to ten percent (10%) of the total contract price;
- c) Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in a sum equivalent to thirty percent (30%) of the total contract price.

Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to CMO-LD.

Failure to submit the required Certificate of Acceptable Performance Security within Eighty (80) calendar days from receipt of Notice of Award shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
