**CANCELLATION OF PURCHASE REQUISITIONS FOR THE PROCUREMENT OF DIESEL GENERATING SETS**

**WHEREAS**, the Purchase Requisitions listed below have the following procurement details;

**WHEREAS**, all the PRs were advertised, remain active and are publicly accessible on both the NPC and PHILGEPS websites;

**WHEREAS**, the procurement of generating sets were deferred due to implementation of corporate wide cost cutting measures to fund the fuel requirements of SPUG Power Plants;

**WHEREAS**, on 11 May 2023, the Corporate Affairs Group (CAG) presented the Revised 2023-2027 Missionary Electrification Plan (MEP) to National Power Board (NP Board) excluding the procurement of generating sets on the affected SPUG Power Plants;

**WHEREAS**, on the same meeting, the NP Board approved the Revised MEP for CY 2023-2027 and further manifested there are no more diesel generating sets to be procured by NPC instead to endeavor the installation of Renewable Energy (RE) facility;

**WHEREAS**, the Logistics Department in its memorandum dated 17 November 2023 and 20 December 2023 sought the confirmation from the Vice President of PES on the cancellation of subject Purchase Requisitions;

**WHEREAS**, the Department Manager of PMD-PES in its memorandum dated 08 January 2024 formally confirmed and requested the cancellation of these PRs considering that these projects were re-programmed to Solar and Hybridization projects on CY 2026 per 2023-2027 MEP;

**WHEREAS**, Section 35.6 (a) of the 2016 Revised IRR of R.A. No. 9184 provides:

*...xxx... the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to*

**a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;**

*...xxx...*

**WHEREAS**, Section 41 (c) of the 2016 Revised IRR of R.A. No. 9184 further provides:

*The HoPE reserves the right to reject any and all Bids, declare a failure of bidding, or not award the contract in the following situations:*

**(a) ...xxx...**

**(b) ...xxx...**

**(c) For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows: (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE... xxxx...**

**NOW, THEREFORE,** We, the Members of the Bids and Awards Committee, resolve, as it hereby resolved, the cancellation/termination of the procurement activities of the above listed Purchase Requisitions (PRs) in order to close the transactions at NPC and PHILGEPS websites pursuant to **Section 35. 6 (a) Section 41 (c)** of the 2016 Revised IRR of Republic Act 9184.
