Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served to Mortar Masters and Concrete Builders for having submitted the Single Calculated and Responsive Bid (SCRB) for the Repair of Dam Apron Water Spill Structure at Pulangi IV HEP, Panadajan, Maragan, Bukidnon under PR No MG-PLM22-503 / Ref. No INFRA2022-PUL-001 in the total contract amount of Eight Million Two Hundred Fifty Thousand Seven Hundred Ninety Nine & 69/100 Pesos (P8,250,799.69).

The price validity is one hundred twenty (120) days, completion period is within Forty (40) calendar days upon receipt of NTP, and delivery site is Pulangi IV HEP, Maragan, Bukidnon.

- Bank Draft/Guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authorized by a Universal or Commercial Bank, if issued by a foreign bank in a sum equivalent to ten percent (10%) of the total contract price.
- Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission or authorized to issue such security in a sum equivalent to thirty percent (30%) of the total contract price.

Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to CMO-LO.

Failure to submit the required Certificate of Acceptable Performance Security within Eight (8) calendar days from receipt of Notice of Award shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
