# TECHNICAL SPECIFICATIONS

#### TS-1.0 GENERAL

This specification covers the features and technical requirements for the supply and delivery of Solar Pathfinder equipment and accessories.

The Supplier shall accept full responsibility for his work including documentation, preparation for shipment, inspection, warranty provisions and compliance with the applicable codes and standards and the requirements of this Specification.

#### TS-2.0 SCOPE OF WORKS

The scope of works shall cover the Supply and Delivery of Solar Pathfinder and other necessary contractor's duties and responsibilities.

The Supplier's scope of works under this Contract shall generally consist of requirements stipulated hereunder.

- 1. Supply and delivery of one (1) unit of Solar Pathfinder equipment complete with digital camera, camera mounting device, horizon mirror, sunshade and support, level, compass, tripod, user's manual, equipment case and analysis software; and
- 2. Supply and delivery of one (1) unit of the latest Meteonorm license software.

### TS-3.0 TECHNICAL DESCRIPTION AND REQUIREMENTS

### Solar Pathfinder

The primary purpose of Solar Pathfinder equipment is to take pictures of the horizon. These pictures shall be used to determine the solar energy input, sunshine duration, and sun exposure reduced by obstacles like trees, houses, or mountains. Photos taken shall also be able to be processed and imported to Meteonorm software application. The new furnished license shall have the latest version of Meteonorm software and shall be compatible to the supplied Solar Pathfinder Equipment.

All equipment to be supplied together with camera, tripod and necessary accessories shall be housed with adequate equipment casing. The digital camera included shall have a minimum resolution of twenty megapixel (20MP) with a thirty-two gigabyte (32GB) removable SD Card.

The camera shall be attached and positioned directly above and parallel to the horizon mirror. This equipment set-up shall be sturdy enough to stand alone.

### Meteonorm License/Software

Meteonorm is a meteorological software application which will be used as reference of climatological data for solar energy across the globe in which it shall be a helping hand to users of engineering design programs for they can access a comprehensive and uniform meteorological data. Meteonorm should also provide calculation of solar radiation thru algorithms and interpolation of multitude data gathered from weather stations, geostationary satellite and globally calibrated aerosol climatology. The data provided by Meteonorm should be categorized by monthly, daily, hourly and minute values since 2010 to present and is constantly updated.

The program should be able to import third party data, and have output formats compatible to something like PVSyst and programs alike. Also the root mean square error in interpolating monthly radiation should not exceed 7%, and for temperature 1.3°C.

### TS-4.0 DELIVERY PERIOD AND LOCATION

The delivery period shall be **NINETY (90) CALENDAR DAYS** reckoned from receipt of Notice to Proceed.

The Solar Pathfinder shall be delivered to the Office of the Vice President of the Power Engineering Services at NPC Head Office, BIR Rd. Cr. Quezon Ave., Diliman, Quezon City.

#### TS-5.0 GUARANTEE

The Supplier shall give full guarantee that all furnished equipment and shall be fully functional and free from defect. This guarantee shall provide a warranty of at least one (1) year. The warranty shall cover that all supplied and delivered equipment are free from defects against materials and workmanship from manufacturing. The supplier shall be responsible for the repair and/or replacement of the defective equipment. Additional expenses regarding the repair and/or replacement of the parts shall be liable to the supplier.

The Supplier shall provide online support to address the problems, defects, noncompliance of the equipment that may arise during the warranty period.

### TS-6.0 MEASUREMENT OF PAYMENT

NPC shall pay the supplier in a per delivery basis. Payment for the delivered items and services shall be based on the quantity of the items supplied to NPC. The amount of payment will be made at the corresponding unit price for the items and services in the Bid Price Schedule. Only upon the acceptance of the items and services, the supplier can collect his payments from NPC.



### 7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

### 8. Eligibility Criteria

- a. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Quotation (LCQ).

### 9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

### 10. Post qualification

Submitted documents of the S/LCQ shall be subjected to post qualification evaluation. The bid that PASSED the Post-Qualification shall be declared as the Single/Lowest Calculated Responsive Quotation (S/LCRQ).

### 11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

### 12. Notice to Supplier

- a. The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
- b. Failure to secure the PO/NTP by the supplier within the said period will mean cancellation of the same and imposition of penalties as prescribed by law.

### 13. PO Effectivity

a. The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

### 14. Terms of Payment

### 15. Warranty

Warranty is dependent upon the nature/type of the item which is included in the offer (i. e. Manufacturer's Warranty.

### 16. Liquidated Damages

.

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

### 17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

### 18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

### 19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

#### 20. Reservation Clause

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.
