Glossary of Terms, Abbreviations, and Acronyms

ABC –Approved Budget for the Contract.

ARCC – Allowable Range of Contract Cost.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

CDA – Cooperative Development Authority.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

Contractor – is a natural or juridical entity whose proposal was accepted by the Procuring Entity and to whom the Contract to execute the Work was awarded. Contractor as used in these Bidding Documents may likewise refer to a supplier, distributor, manufacturer, or consultant.

CPI – Consumer Price Index.

DOLE – Department of Labor and Employment.

DTI – Department of Trade and Industry.

Foreign-funded Procurement or Foreign-Assisted Project –Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

GFI – Government Financial Institution.

GOCC –Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term "related" or "analogous services" shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. 1. Scope of Bid

The Procurement Project (referred to herein as "Project") is for the construction of Works, as described in Section VI (Specifications).

2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for CY 2021 in the amount of *Three Hundred Thousand Pesos [PHP 600,000.00]*.
- 2.2. The source of funding is:
 - a. GOCC and GFIs, the Corporate Operating Budget.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manual and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or invitation to bid by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have inspected the site, determined the general characteristics of the contracted Works and the conditions for this Project, such as the location and the nature of the work; (b) climatic conditions; (c) transportation facilities; (c) nature and condition of the terrain, geological conditions at the site communication facilities, requirements, location and availability of construction aggregates and other materials, labor, water, electric power and access roads; and (d) other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, Coercive, and Obstructive Practices

The Procuring Entity, as well as the Bidders and Contractors, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. The Bidder must have an experience of having completed a Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted, if necessary, by the Bidder to current prices using the PSA's CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184.

A contract is considered to be "similar" to the contract to be bid if it has the major categories of work stated in the **BDS**.

- 5.3. For Foreign-funded Procurement, the Procuring Entity and the foreign government/foreign or international financing institution may agree on another track record requirement, as specified in the Bidding Document prepared for this purpose.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.2 of the 2016 IRR of RA No. 9184.

6. Origin of Associated Goods

There is no restriction on the origin of Goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN.

7. Subcontracts

7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than fifty percent (50%) of the Project.

The Procuring Entity has prescribed that:

a. Subcontracting is not allowed.

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents Comprising the Bid: Eligibility and Technical Co nponents

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 10.2. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. For Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.
- 10.3. A valid PCAB License is required, and in case of joint ventures, a valid special PCAB License, and registration for the type and cost of the contract for this Project. Any additional type of Contractor license or permit shall be indicated in the BDS.
- 10.4. A List of Contractor's key personnel (e.g., Project Manager, Project Engineers, Materials Engineers, and Foremen) assigned to the contract to be bid, with their complete qualification and experience data shall be provided. These key personnel must meet the required minimum years of experience set in the **BDS**.
- 10.5. A List of Contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, must meet the minimum requirements for the contract set in the **BDS**.

11. Documents Comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 11.2. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.3. For Foreign-funded procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Alternative Bids

Bidders shall submit offers that comply with the requirements of the Bidding Documents, including the basic technical design as indicated in the drawings and specifications. Unless there is a value engineering clause in the **BDS**, alternative Bids shall not be accepted.

13. Bid Prices

All bid prices for the given scope of work in the Project as awarded shall be considered as fixed prices, and therefore not subject to price escalation during contract implementation, except under extraordinary circumstances as determined by the NEDA and approved by the GPPB pursuant to the revised Guidelines for Contract Price Escalation guidelines.

14. Bid and Payment Currencies

- 14.1. Bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 14.2. Payment of the contract price shall be made in:
 - a. Philippine Pesos.

15. Bid Security

15.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.

15.2. The Bid and bid security shall be valid until *One Hundred Twenty (120)*Calendar Days from the Scheduled Bid Opening. Any bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

16. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission to the given website or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

17. Deadline for Submission of Bids

The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

18. Opening and Preliminary Examination of Bids

18.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

18.2. The preliminary examination of Bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

19.1. The Procuring Entity's BAC shall immediately conduct a detailed evaluation of all Bids rated "passed" using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of 2016 revised IRR of RA No. 9184.

- 19.2. If the Project allows partial bids, all Bids and combinations of Bids as indicated in the **BDS** shall be received by the same deadline and opened and evaluated simultaneously so as to determine the Bid or combination of Bids offering the lowest calculated cost to the Procuring Entity. Bid Security as required by **ITB** Clause 16 shall be submitted for each contract (lot) separately.
- 19.3. In all cases, the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184 must be sufficient for the total of the ABCs for all the lots participated in by the prospective Bidder.

20. Post Qualification

Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS), and other appropriate licenses and permits required by law and stated in the **BDS**.

21. Signing of the Contract

The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

2. Sectional Completion of Works

If sectional completion is specified in the **Special Conditions of Contract** (SCC), references in the Conditions of Contract to the Works, the Completion Date, and the Intended Completion Date shall apply to any Section of the Works (other than references to the Completion Date and Intended Completion Date for the whole of the Works).

3. Possession of Site

- 4.1. Each layer shall be moistened or dried as directed for maximum compact. No succeeding layer shall be placed thereon unless the preceding layer has been inspected and approved by NPC.

iii. CONCRETE

A. SCOPE

In accordance with the specification contained in this section, the contractor shall furnish all materials, labor, equipment and tools and perform all concreting works in accordance with the drawing, or as otherwise directed

B. CLASS OF CONCRETE

Class of concrete or strength shall be as indicated on the drawing, which shall conform to the minimum requirement for compressive strength indicated on the provision of NSCP for concrete and, in no case, shall not be less than 20.7MPa.

C. MATERIALS

1. CEMENT

Cement for concrete works shall be furnished by Contractor and conform to the requirements of the lates edition of the standard specification for Portland Cement (ASTMC150)

Unless otherwise specified, cement shall be ordinary Portland Cement. Type I for general construction which concrete is not in contact with soils or ground water and Type II for concrete in contact with soil or ground water. However, the use of Portland Pozzolan Cement Type IP meeting the

Water for use in concrete shall be subject to the approval of the NPC. It shall not be salty and shall be reasonably clear and free from oil, acid, inurious alkali or vegetable matter

4. AGGREGATES

All coarse and fine aggregates shall consist of hard, tough, durable and clean, uncoated parties. All foreign materials and dust shall be removed by processing. Aggregates shall generally be rounded and reasonably free from thin, flat and elongated particles in all sizes and well graded from coarse to fine.

FORMWORK

Timber, lumber and plywood to be used for falsework and formwork shall be sound and shall comply with the requirements of this specification. Use forms where a smooth form finish is required. Lumber shall be squere-edged or tongue-and-groove boards free or raised grain, knotholes and the other surfaces defects, steel when used shall conform to the requirements of the ASTM A36. Steel form surfaces shall not contain irregularities, dents or sags.

Form shall be wood, plywood, or steel, wood forms for surfaces exposed to view in the finished structure and requiring s smooth form finish, shall be plywood. For unexposed surfaces, undressed square-edge lumber may be used. Forms for surfaces requiring special finish shall be plywood, or shall be lined with plywood, a non-absorptive, hard-pressed fiberboard, absorptive-type lining or other suitable materials. Plywood, other than for lining, shall be concrete-form plywood free of raised grain, torn surfaces, worn edges, patches, or other surfaces defect, which would impair the texture of the concrete surface. Surface of steel forms shall be free from irregularities, dents and sags.

D. CONCRETING

1. GENERAL

All concrete shall be poured on dry and clean surfaces.

Mixing of concrete shall conform to the requirements of ACI Code for Concrete Construction.

5. PLACING CONCRETE

Concrete shall be conveyed from mixers to the forms or to the place of deposit as rapidly as possible and by methods that will prevent segregation or loss of ingredients.

Earth surfaces, upon which concrete shall be placed, shall be thoroughly cleaned of loose or semi-detached or unsound rock particles. Before placing concrete all surfaces shall be welted thoroughly to keep them in a completely moist condition, after which leveling mortar of the same cement ratio as the concrete mix complete contact between concrete and the leveled surface.

6. FINISHING CONCRETE

After the concrete has been deposit, distributed and vibrated, the concrete shall be struck off and screened by mechanical means approved by the NPC. The finishing machining shall be of the screening and troweling type designed and operated both to strike off and to consolidate. Hand finishing may be employed when suitable finishing machines are not available. Finishing of concrete shall be done, as directed. To the satisfaction of the NPC.

7. REMOVAL OF FORMS

Blocks and bracing shall be removed at the time the forms are removed and in no case shall any portion of the wood forms be left in the concrete.

False removal for continuous structures shall be as directed by NPC but in which case shall be temporarily support such that the structure is gradually subjected to its working stresses. False work shall not be released in any span until the strength specified hereunder is attained

When concrete strength test are to be used as basis for the removal of forms and supports. The compressive strength of concrete must meet the following minimum requirements:

8. CURING AND PROTECTION

Concrete shall be cured for period of not less than fourteen (14) consecutive days by keeping the surfaces of concrete continuously (not periodically) wet. When tongue and groove forms were used and left in place of curing, they shall be kept wet at all times, prevent opening at the joints and drying out of the concrete.

9. TOLERANCE AND REPAIR FOR CONCRETE CONSTRUCTION

All equipment and materials to be supplied by the contractor shall be new and unused, of current manufacture, and of the highest Grade and the best of their respective kinds, and free from defects and imperfections. They shall be suitable for their intended purpose and shall comply with all applicable regulations, quality and dimension standards.

The work shall be performed and completed in a high quality workmanship in accordance with all applicable codes, standards and generally accepted modern practice in the Supply, Fabrication, installation and test of the waste oil storage tank, auxiliary Equipment/Accessories and Associated Facilities. To have quality workmanship, only technicians skilled in the respective trades shall be employed.

FOST shall provided with necessary connections to all pipe works as shown on the drawing which include tapping points for instrumention, manholes, vent, drains and other appurtenances such as stairways, hand railings and etc.

The work shall comprise all labor, tools, supply of appurtenant materials and other incident for all works enumerated hereunder in accordance with the specifications contained herein and as shown in the drawing or otherwise directed by the NPC.

C. MATERIALS

All materials to be used for the WOST shall be new and unused and of the best grade and quality for the purpose. All manufactured items shall be standard commercial products of reputable manufacturers and in case where the materials shown in the drawing are not covered by the standard or specifications, the supplier/contractor shall furnish high quality materials which are acceptable to the applicable specifications and provisions of ASTM A-36 and AISC Standard specification of equivalent approved by NPC.

All materials used for pipes and fittings shall be carbon steel. Schedule 40, seamless, conforming to ASTM A53 Grade B, unless otherwise approved. Valves shall be of all bronze materials, unless otherwise specified.

D. DESIGN AND CONSTRUCTION

The WOST shall be of all welded construction designed, fabricated, constructed and erected in accordance with the requirement and shall be supplied with manholes, stairways, nozzles, associated valves and piping works as shown on the drawings.

The FOST shall be rectangular and with vent hole and manhole.

The WOST shall be designed fr erection on a concrete foundation and shall conform to standard requirements. The foundation shall be in accordance with the requirements shown on the Civil Works Drawing.

E. SHELL

The shell plates of the FOST shall be constructed of not less than the thickness (corrosion allowance included) specified and shown on the drawings.

The shell plates of the FOST shall be designed to have all courses truly vertical. Shell vertical joints shall be by butt-weld with complete penetration and fusion as attained by double welding or by other means which obtain the same quality of deposited weld metal on the inside and the outside weld surface. Vertical joints in adjacent shell courses shall not be in alignment, but shall be offset from each other a minimum distance of five (5) times the thickness of the thicker course at the offset point.

Shell horizontal joints shall be by butt weld with complete penetration and fusion. Abutting shell plates have a common vertical centerline.

Shell plates of standard size with a minimum thickness shall be 5mm or as shown on drawings.

F. SHELL ATTACHMENT AND TANK APPURTENANCES

The FOST shall be provided with the following appurtenances generally arrange in accordance with the bid drawing:

G. MANHOLES AND NOZZLES

Manholes and nozzles shall be provided and constructed in accordance with the bid drawings. The minimum dimension of roof manhole shall be 20in. by 20 in. with cover. The cover for the manhole must have handle.

H. HOLDING DOWN BOLTS

Holding down bolts shall be provided to protect the tank from skidding or overturning due to due to wind load or earthquake load. Number of size of bolts shall be provided as shown on drawing and equally spaces high strength bolts conforming to ASTM A-307 or approved equivalent.

I. PIPING, VALVES AND FITTINGS

All valves that are connected to the tank nozzles shall have flanged ends.

J. ERECTION

The Contractor shall furnish all labor, tool, welding equipment and cables, false work, scaffolding and other equipment necessary for the erection of the tank complete and ready for use, lifting lugs attached to the tank for er3ction purposes shall be removed by contractor and any noticeable project of weld metal shall be chipped-off.

Tack weld, a weld made to hold parts of a weldment in proper alignment until final welds are made, shall not be considered as having any strength value in the finished structure.

The reinforcement need not be removed except it exceeds the maximum acceptable thickness. During the welding operation, plates shall be held close contact at all lap joints. Tack welds used in the assembly of vertical joints of the shell shall be removed when such joint are welded manually. Tack welds, whether removed or left in the place, shall be made using fillet or butt weld procedure, tack weld to be in place shall be made by qualified welder and shall be examined visually for defects, defective tack shall be removed.

Misalignment in the complete vertical joint shall not exceed 10% of theplate thickness or 1.6mm, whichever is larger.

K. TEST AND INSPECTION

Test and inspection of all materials and equipment shall be performed in accordance with the requirements of all applicable codes and standards, unless otherwise stated in the specification.

Upon completion of works, the Contractor shall conduct and perform test and inspection, shall be in accordance with the approved test procedure.

Considerable porosity in the roof joints or of cracking shall be added with bead of weld metal laid over the affected portion. Mechanical caulking is not permitted for any other repairs. Repairs of defect discovered after the tank has been subjected to hydrostatic test shall be made with the water level at least 300mm below the point being repaired or the tank empty if repair is on or near the tank bottom.

All repaired weld shall be checked by repeating original inspection procedure and by repeating one of the test methods.

M. PAINTING

The tank and other surface shall be painted in accordance with first class standard practices suitable for the purpose.

All paints and shop primer to be used shall be of standard types of a well-known manufacturer subject to the approval of NPC.

Prior to painting all weld spatter, mill scale, burrs, rust loose particles, and flux shall be removed. Grinding and deburring shall be performed with a wheel that will assure a clearly surface.

All cleaned surfaces shall be primed.

Application of paint shall be in accordance with the manufacturers recommendations and standard practices. No painting shall be applied on wet or damp surfaces.

The tank external surface, appurtenances and other surfaces shall be painted with zinc rich epoxy polyamide primer for primer coat and polyurethane enamel for final coating.

The tank inside surface including structural shall be painted with zinc rich epoxy polyamide primer and polyamide amine cured epoxy coating for final coating.

B. CLASS OF CONCRETE

Class of concrete or strength shall be as indicated on the drawing, which shall conform to the minimum requirement for compressive strength indicated on the provision of NSCP for concrete and, in no case, shall not be less than 20.7MPa.

G. MATERIALS

6. CEMENT

Cement for concrete works shall be furnished by Contractor and conform to the requirements of the latest edition of the standard specification for Portland Cement (ASTMC150)

Unless otherwise specified, cement shall be ordinary Portland Cement. Type I for general construction which concrete is not in contact with soils or ground water and Type II for concrete in contact with soil or ground water. However, the use of Portland Pozzolan Cement Type IP meeting the

7. REIMFORCING STEEL

8. WATER

Water for use in concrete shall be subject to the approval of the NPC. It shall not be salty and shall be reasonably clear and free from oil, acid, inurious alkali or vegetable matter

9. AGGREGATES

All coarse and fine aggregates shall consist of hard, tough, durable and clean, uncoated parties. All foreign materials and dust shall be removed by processing. Aggregates shall generally be rounded and reasonably free from thin, flat and elongated particles in all sizes and well graded from coarse to fine.

10. FORMWORK

Timber, lumber and plywood to be used for falsework and formwork shall be sound and shall comply with the requirements of this specification. Use forms where a smooth form finish is required. Lumber shall be squere-edged or tongue-and-groove boards free or raised grain, knotholes and the other surfaces defects, steel when used shall conform to the requirements of the ASTM A36. Steel form surfaces shall not contain irregularities, dents or sags.

Form shall be wood, plywood, or steel, wood forms for surfaces exposed to view in the finished structure and requiring s smooth form finish, shall be plywood. For unexposed surfaces, undressed square-edge lumber may be used. Forms for surfaces requiring special finish shall be plywood, or shall be lined with plywood, a non-absorptive, hard-pressed fiberboard, absorptive-type lining or other suitable materials. Plywood, other than for lining, shall be concrete-form plywood free of raised grain, torn surfaces, worn edges, patches, or other surfaces defect, which would impair the texture of the concrete surface. Surface of steel forms shall be free from irregularities, dents and sags.

H. CONCRETING

10. GENERAL

All concrete shall be poured on dry and clean surfaces.
