Directors/Alternates are briefed on NPC's power plant operations including rate-fixing/tariff-setting procedures while the Corporate Secretary holds special briefing on the privileges and responsibilities of Member of the National Power Board.

For **CY 2019**, NPC provided orientation programs for new alternates from the Department of Energy (DOE) and the Department of Environment and Natural Resources (DENR).

Moreover, as part of their continuing education, the Management and the Office of the Corporate Secretary facilitated the following activities for CY 2019:


