ORDER

On 22 April 2022, National Power Corporation (NPC) filed a *Petition* dated 02 March 2022, seeking the Commission's approval of the recovery of the Calendar Year (CY) 2020 revenue shortfall from the Universal Charge for Missionary Electrification (UC-ME) and the corresponding adjustment of the UC-ME with prayer for the issuance of provisional authority.

In the *Order* and *Notice of Virtual Hearing*, both dated 18 May 2022, the Commission has set the instant *Application* for hearing on the following dates: a) 05 July 2022 for the determination of compliance with the jurisdictional requirements and expository presentation; b) 12 July 2022 for pre-trial conference and presentation of evidence; and 19 and 20 July 2022 for the presentation of evidence.

During the hearing held on 05 July 2022, NPC presented its proof of compliance with the publication and notice requirements pursuant to the Commission's *Order* dated 18 May 2022.

As proof of its publication requirements, NPC submitted copies of the newspapers, wherein the *Notice of Virtual Hearing* dated 18 May 2022 was published, namely: (1) *The Philippine Star* newspapers dated 09 June 2022, and 21 June 2022; and (2) *The Manila Times* newspapers dated 09 June 2022, and 21 June 2022.

Upon examination of the said newspapers, the Commission noted that the first publication was made on 09 June 2022, while the second publication was made on 21 June 2022. The Commission found that the dates of both publication failed to comply with the required two (2) successive week intervals pursuant to the Commission's *Order* dated 18 May 2022 and Section 43¹ of Republic Act No. 9136, otherwise known as the Electric Power Industry Reform Act (EPIRA) of 2001.

In view thereof, the Commission declared NPC to have failed to comply with the jurisdictional requirements and cancelled the hearings of the instant case.

Subsequently, on 12 July 2022, NPC filed a *Motion for Reconsideration (Re: Order dated 05 July 2022)*² (Motion). In the said *Motion*, NPC prayed that the Commission's *Order* dated 05 July 2022 be set aside and a new one be issued, *to wit:*

- 1. Admitting Petitioner NPC's documents and give due course to its Jurisdictional Compliance;
- 2. Acquiring jurisdiction over the instant Petition; and
- 3. Setting the case for trial on the merits.

In its *Motion*, NPC raised that the Commission erred in holding that it has not acquired jurisdiction over the instant case solely on the basis of the alleged defect in the successive publication of the *Notice of Virtual Hearing*.

NPC alleged that it had substantially complied with the jurisdictional requirements of the Commission. Further, NPC stated that the purpose of the Commission in directing NPC to cause the publication of its *Notice of Virtual Hearing* is to notify and inform the public. NPC explained that such purpose has been fully satisfied by NPC as the date of the last publication which was on 21 June 2022 was

made not less than ten (10) days prior the date of the scheduled hearing which was on 05 July 2022. In effect, NPC submits that the public was given sufficient time to participate and intervene in the proceeding.

The Commission finds the *Motion* of NPC bereft of merit, and therefore, the same should be denied.

The required publication of the *Notice of Virtual Hearing* is a jurisdictional requirement which vests the Commission with the authority to hear and determine the instant *Application*. The said jurisdictional requirements is mandated under Section 43³ of the EPIRA. Moreover, the Commission, in the *Order* dated 18 May 2022, clearly directed NPC to comply with said publication requirements, *to wit*:

XXX

Accordingly, NPC is hereby directed to:

 Cause the publication of the attached Notice of Virtual Hearing in <u>two (2) newspapers of nationwide</u> <u>circulation</u> in the Philippines at its own expense, <u>twice (2x)</u> within <u>two (2) successive weeks</u>, the dates of publication not being less than <u>seven (7) days apart</u>, and the date of the <u>last publication to be made not later than ten (10)</u> <u>days before the date of the scheduled initial hearing</u> XXX

(Emphasis and underscoring supplied.)

Based on the foregoing, for the Commission to acquire jurisdiction over the instant case, it is not just enough for NPC to establish that it had complied with the publication of the *Notice of Virtual Hearing* in two (2) newspapers of nationwide circulation. NPC must likewise establish that these publications were made within two successive weeks.

In the case of NPC, its first publication was made on 09 June 2022 while its second publication was made on 21 June 2022, which is a week after the first publication. Clearly, the dates between the first and the second publication failed to comply with the required two (2) successive week intervals pursuant to the Commission's *Order* dated 18 May 2022 and the EPIRA.

Considering the foregoing, the Commission maintains its ruling during the 05 July 2022 hearing. In view thereof, the *Motion* of NPC is hereby denied.

ACCORDINGLY, the Commission hereby sets anew the instant *Petition* for determination of compliance with the jurisdictional requirements, expository presentation, Pre-trial Conference and presentation of evidence on the following dates and online platform for the conduct thereof, pursuant to Resolution No. 09, Series of 2020⁴ dated 24 September 2020 and Resolution No. 01, Series of 2021 dated 17 December 2020 (ERC Revised Rules of Practice and Procedure):⁵

ACCORDINGLY, NPC is hereby directed to:

1. Cause the publication of the attached *Notice of Virtual Hearing* in two (2) newspapers of nationwide circulation in the Philippines at its own expense, twice (2x) within two (2) successive weeks, the dates of publication not being less than seven (7) days apart, and the date of the last

publication to be made not later than ten (10) days before the date of the scheduled initial hearing;

- 2. Furnish with copies of this *Order* and the attached *Notice of Virtual Hearing* the Offices of the Provincial Governor, the City and Municipal Mayors, and the Local Government Unit (LGU) legislative bodies within the affected areas and the City Mayor and LGU legislative body of Quezon City for the appropriate posting thereof on their respective bulletin boards;
- 3. Inform the consumers within the affected area, by any other means available and appropriate, of the filing of the *Petition* its reasons therefor, and of the scheduled hearing thereon;
- 4. Furnish with copies of this *Order* and the attached *Notice of Virtual Hearing* the Office of the Solicitor General (OSG), the Commission on Audit (COA), and the Committees on Energy of both Houses of Congress. They are hereby requested, if they so desire, to send their duly authorized representatives and attend the scheduled hearings scheduled hearing; and
- 5. Furnish with copies of the *Petition* and its attachments all those making requests therefor, subject to the resolution of the prayer for confidential treatment, if any, and reimbursement of reasonable photocopying costs.⁶

Within five (5) calendar days prior to the date of the virtual hearing, NPC must submit to the Commission via electronic mail (e-mail) at <u>docket@erc.ph</u>, copy furnish the Legal Service through <u>legal@erc.ph</u>, the scanned copies of their written compliance with the aforementioned jurisdictional requirements attaching therewith, methodically arranged and duly marked the following:

1. The evidence of publication of the attached *Notice of Virtual Hearing* consisting of affidavits of the Editors or Business Managers of the newspapers where the said *Notice of Virtual Hearing* was published, and the complete issues of the said newspapers;

- 2. The evidence of actual posting of this *Order* and the attached *Notice of Virtual Hearing* consisting of certifications issued to that effect, signed by the aforementioned Governors, Mayors and LGU legislative bodies or their duly authorized representatives, bearing the seals of their offices;
- 3. The evidence of other means employed by NPC to inform the consumers within the affected area of the filing of the *Petition*, its reasons therefor, and of the scheduled hearings thereon;
- 4. The evidence of receipt of copies of this *Order* and the attached *Notice of Virtual Hearing* by the OSG, the COA, and the Committees on Energy of both Houses of Congress;
- 5. The evidence of receipt of copies of the *Petition* and its attachments by all those making requests therefor, if any; and
- 6. Such other proof of compliance with the requirements of the Commission.

Moreover, NPC is hereby required to post on its bulletin boards, the scanned copies of the foregoing jurisdictional requirements, together with the newspaper publications and certifications issued by the concerned Office of the Provincial Governors, City and Municipal Mayors and Local Legislative Bodies, and to submit proof of its posting thereof.

NPC and all interested parties are also required to submit via email at <u>docket@erc.ph</u>, copy furnish the Legal Service through <u>legal@erc.ph</u>, **at least five (5) calendar days** before the date of the scheduled virtual hearing and Pre-trial Conference, their respective Pre-Trial Briefs containing, among others:

- 1) A summary of admitted facts and proposed stipulation of facts;
- 2) The issues to be tried or resolved;

- 3) The documents or exhibits to be presented, stating the purposes and proposed markings therefor, which should also be attached to the Pre-trial Brief; and
- 4) The number and names of the witnesses, with their written testimonies in a Judicial Affidavit form attached to the Pretrial Brief.

NPC must ensure that all the documents or exhibits proposed to be presented have already been duly submitted to the Commission **at least five (5) calendar days** before the date of the scheduled initial virtual hearing and Pre-trial Conference pursuant to the preceding paragraph.

Failure of NPC to comply with the above requirements within the prescribed period shall be a ground for cancellation of the scheduled hearing, and the resetting of which shall be six (6) months from the said date of cancellation.

NPC must also be prepared to make an expository presentation of the instant *Petition*, aided by whatever communication medium that it may deem appropriate for the purpose, in order to put in plain words and explain, for the benefit of the consumers and other concerned parties, the nature of the *Petition* with relevant information and pertinent details substantiating the reasons and justifications being cited in support thereof.

NPC is hereby directed to file a copy of its Expository Presentation via e-mail at <u>docket@erc.ph</u>, copy furnish the Legal Service through <u>legal@erc.ph</u>, **at least five (5) calendar days** prior to the scheduled virtual hearing. NPC shall also be required, upon the request of any stakeholder, to provide an advance copy of its expository presentation, **at least five (5) calendar days** prior to the scheduled virtual hearing.

Any interested stakeholder may submit its comments and/or clarifications **at least one (1) calendar day** prior to the scheduled virtual hearing, via e-mail at <u>docket@erc.ph</u>, copy furnish the Legal Service through <u>legal@erc.ph</u>. The Commission shall give priority to the stakeholders who have duly submitted their respective comments and/or clarifications, to discuss the same and propound questions during the course of the expository presentation.

NPC is hereby directed to submit, either through personal service, registered or ordinary mail/private courier, one (1) set of the original or certified true hard/printed copy/ies of its Jurisdictional Compliance, Expository Presentation, Pre-trial Brief, and Judicial Affidavit/s of witness/es, **within five (5) working days** from the date that the same were electronically submitted, as reflected in the acknowledgment receipt e-mail sent by the Commission. Similarly, all interested parties who filed their Petition for Intervention or Opposition are required to submit the hard/printed copy thereof within the same period through any of the available mode of service.

Finally, NPC, including its authorized representative/s and witness/es, are hereby directed to provide the Commission, thru <u>legal.virtualhearings@erc.ph</u>, with their respective e-mail addresses upon receipt of this *Order*. The Commission will send the access link/s to the aforementioned hearing platform **within five (5) working days** prior to the scheduled hearing.
