The National Power Corporation (NPC) wishes to inform all concerned DAMA claimants of the following update and reminders regarding the processing of claims:

1. **New Status Categories.** We have introduced an additional status categories to reflect the state of certain claims:
 - a. For Commission on Audit (COA)-validated claims, we now have Step 8: On hold pending NPC and PSALM's resolution of the withholding tax concerns; and
 - b. For claims not validated by COA: Disqualified

Given this, here are the updated figures in a per status basis:

However, for specific details and/or requirements needed, NPC can only release them directly to the claimant or their duly authorized representative on record/ petitioner in the COA money claim or legal counsel as contained in the Supreme Court decision. This is to ensure the privacy and protection of personal information of all claimants.
